The Westfield PAL "B" football team completed their regular season with a 21-6 win over Springfield, on November 17 at Kehler Stadium in championship. The teams battled in the driving rain on muddy-field conditions that favored the defense.

Westfield's defense had a hand in all three of its touchdowns. In the first quarter, defensive lineman John Dugan picked up a Springfield fumble and ran it 20 yards for the touchdown. Running back Mike Phillips scored the PAT.

In the third quarter, linebacker Ryan Brand pounced on a Springfield fumble in the end zone for a touchdown. QB Kevin Neylan called

his own number for the PAT.

Springfield took advantage of good field position, resulting from a bad snap on a Westfield punt attempt, and scored on a one-yard dive. Later, Westfield linebacker Patrick Stanley intercepted a pass at the Springfield 13. Four plays later, Phillips plunged three yards for the TD. Brand pounced in for the PAT.

Westfield, led by Head Coach Owen Brand, Offensive Coordinator John Dugan and Defensive Coordinators Humberto Vall-Ilobera and Scott Selert finished the regular season with a record of 8-1. The team seeks to avenge their only loss when they face undefeated Millburn in the Super Bowl on November 24 in Scotch Plains.

Area Flag Gridmen Get High League Honors

Ed Pedicini of Clark, defensive lineman for the Union Brewers, finished first among all linemen in the ACFL 2002 Men's Fall Flag Football League with 14 sacks in eight regular-season games - besting the second place finisher by three.

The Brewers allowed only 111 points on the season, averaging a mere 13.8 points allowed per game (sixth overall). Coincidentally, the team also finished sixth in points scored per game, with 22.5, scoring 180 total points.
