Dr. Julia Bhasin, 55, Was Educator; Known For Compassion and Spirit

Dr. Julia Irizarry Bhasin, a Westfield resident for 21 years, died at Overlook Hospital in Summit on Sunday, November 17, 2002. She was 55 years old. She belonged to the Holy Trinity Roman Catholic Church in Westfield and was a Sunday School teacher there.

Julia grew up in Williamsburg, Brooklyn in a loving Puerto Rican family composed of Papi, Mami (Reyes and Ana Irizarry), sister (Vivian) and brother (Reyes). She was also very close with her older brothers, Justin and Ferdinand Irizarry.

Active in her local church in Brooklyn, the Transfiguration Roman Catholic Church, she never questioned her destiny of going off to Brandeis University. There, she fell in love with a young international student from Bombay, India, Keval Krishan Bhasin, who she married in 1973.

She delighted in her three sons, Nicholas, Paul and Andy; a screenwriter in Los Angeles, a classical musician in Chicago and a Northwestern University sophomore violinist.

The first in her family to attend college, Julia received her Bachelor of Arts Degree in History from Brandeis University in 1969; her Master of Arts Degree in Education from Harvard University in 1970 and her Doctorate of Education from Teachers College, Columbia University in 1990.

She focused her original research on the teaching of reading skills and strategies to bilingual students,

a specialty mix of Linguistics, Educational Theory and Practice.

Since 1970, Dr. Julia Irizarry Bhasin taught at Baruch College, City University of New York. With unending devotion to her students, she was a dedicated teacher. For more than 30 years, Julia was a strong influence on her students, who constantly sought her out to tell her how much they learned from her.

Sharing her mother's profound compassion for all living things, Julia rescued and adopted abandoned cats and dogs. Her deep desire to nurture life in every form also inspired her to tend to her garden with love and care.

Like her father, she had a certain joie de vivre. She leaves behind innumerable family and friends to whom she gave her love, her warm laughter and her loyal friendship. She never just added to a group; she helped define, shape and support it.

Funeral services were held yesterday, Wednesday, November 20, at the Gray Funeral Home, 318 East Broad Street in Westfield.
