WHEREAS, such Resolution of certification shall be adopted by the Governing Body no later than forty-five days after the receipt of the annual audit, as per the regulations of the Local Finance Board; and

WHEREAS, all members of the governing body have received and have familiarized themselves with, at least, the minimum requirements of the Local Finance Board of the State of New Jersey, as stated aforesaid and have subscribed to the affidavit, as provided by the Local Finance Board; and

WHEREAS, failure to comply with the promulgations of the Local Finance Board of the State of New Jersey may subject the members of the local governing body to the penalty provisions of R.S. 52:27BB-52 to wit:

R.S. 52:27BB-52 - "A local officer or member of a local governing body who, after a date fixed for compliance, fails or refuses to obey an order of the Director of Local Government Services, under the provisions of this Article, shall be guilty of a misdemeanor and, upon conviction, may be fined not more than one thousand dollars (\$1,000.00) or imprisoned for not more than one year, or both, in addition shall forfeit his office."

NOW, THEREFORE, BE IT RESOLVED that the Board of Chosen Freeholders of the County of Union hereby states that it has complied with the promulgation of the Local Finance Board of the State of New Jersey dated July 30, 1968 and does hereby submit a certified copy of this Resolution and the required affidavit to said Board to show evidence of said compliance.

### Westfield Resident Writes to Stop 'Super' Superintendent Bill

The Senate Bills (S7 or S10) likely will be reintroduced beginning January 8. We need everyone to contact (call, email and letter write) all New Jersey representatives, not just our own. Every little bit counts! You can make a difference.

Please take a minute to email or call your Senator and encourage opposition to this legislation, which will take local control of the schools away from local residents and centralize all decisions with a "super" superintendent run out of the county office. For us in Westfield, it means that a political appointee from Union County will make all decisions, including the ability to veto voter approved budgets for our schools. Any property tax savings are not clear with this part of the proposed bills S10/A4 and S7/A4. Although Union county is supposedly not earmarked for this legislation at the moment, who knows when that can change?

Please ask them to slow down and hold this bill as a work in progress - it is in no shape to become law. Encourage your

spouses and all other registered voters in your home to do the same. The negative impact it will have on our schools could be tremendous. I also encourage you to share this with friends and family in other districts and counties in NJ. The message must be heard from all parts of the state. Annie's Gourmet Kitchen, L.L.C. seeks preliminary and final site plan approval and associated variances and waivers to use premises commonly known as 235 Elmer Street (Lot 15, Block 3113) for meat preparation and sale and delivery of meals. This property is in the GB-3 Zone and was previously occupied by the Westfield Spine Center and before that by McIntyre's for the sale and service of lawn mower equipment.

Applicant seeks variances from the following:

List of Existing Non-Conforming Conditions that will Continue:

Section 11.28E.1 of the Land Use Ordinance. Ordinance requires minimum front yard of 11.7 feet. Existing and proposed is 0.

Section 11.28E.2 of the Land Use Ordinance. Ordinance requires minimum side yard of 5 feet. Present and proposed is 1 foot.

Section 11.28E.6 of the Land Use Ordinance. Ordinance requires maximum all improvement coverage not to exceed 70%. Present and proposed is 90%.

Section 17.04A of the Land Use Ordinance. Ordinance requires minimum parking space dimensions of 9 feet x 20 feet. Five parking spaces are 9 1/2 feet x 17 feet, four parking spaces are 9 feet x 17 feet and one parking space is 12 feet x 15 feet. The handicapped parking space is 21 feet x 17 feet.

Section 17.05B of the Land Use Ordinance. Ordinance requires driveway dimension of 20 feet. Present and proposed is 14 feet.

Section 11.28E.7 of the Land Use Ordinance. Ordinance requires front yard landscaping. Present and proposed has no landscaping because there is no front yard.

New C40:55D-70c Variances Requested:

Section 17.02C.7(S) of the Land Use Ordinance. Ordinance requires 23 parking spaces for restaurant. Proposed is 11 spaces.

Sign Variances Section 16.04E(1)(a) of the Land Use Ordinance. Ordinance permits one sign at main public entrance. Main public entrance is at side of building immediately adjacent to driveway. Proposed is two signs, one of which will be a roof sign and the other will be a wall sign. Neither sign will be located at the main public entrance.

Section 16.04E(1)(b) of the Land Use Ordinance. Ordinance requires that the mounting height of sign shall not exceed the height of the ground floor, or twelve (12) feet, whichever is less. The two proposed signs exceed 12 feet.

Section 16.04E(1)(d) of the Land Use Ordinance. Ordinance requires that vertical dimensions of sign cannot exceed 30 inches. Proposed is 36 inches.

Section 16.07L of the Land Use Ordinance. Ordinance prohibits roof signs. One of the proposed signs is located on the mansard roof.

Further variances, waivers or exceptions from certain requirements of the Westfield Land Use Ordinance may also be sought as appropriate.
