

Rotary Club Announces Its Scholarship Recipients

WESTFIELD - The letter sent to 27 high school seniors from Mark Zenobia, Chairman of the Westfield Rotary Club Foundation's Scholarship Committee began, "What are you doing for lunch on June 6?"

This was the first notice that these students were winners of scholarships totaling \$92 thousand offered by the club, and that they and a guest were invited to the club's annual Scholarship Presentation Luncheon to learn the amount of their scholarship and to pick up a certificate. Mr. Zenobia said that Rotary's defined criteria for consideration are academic achievement, financial need and community service. Members of the 2006 committee were Alison Brafman, Mary Ellen O'Boyle, Roger Love, Liz Ennsin, Edred Shen and Nancy Jackson.

According to Mrs. Jackson, Rotary club president, more than \$2.8 million have been awarded Westfield scholars through the years. In addition to a group of scholarships funded by proceeds from the club's annual Pancake Day, other fundraisers during the year and its own scholarship managed fund, states Mrs. Jackson, the club administers several scholarships on behalf of the Westfield Foundation. Barbara Frantz, president of the foundation, was on hand to present the two top scholarships in honor of the late Charles and Florence Wallace totaling \$15,000 over the course of four years to Sarah Godfrey, who will attend Harvard University and to Maurice Blackmon, who will attend Pennsylvania State University.

Katherine Clark was presented with the Westfield Rotary Club Foundation \$10,000 four year scholarship by the committee. The Rotary committee also presented Yue Zhu with a \$5,000 scholarship toward her studies at New York University.

Members of the Rotary Scholarship Committee presented two \$5,000 scholarships in honor of Harry Sturcke, a member of the club since 1938 and major donor to its foundation, to Thomas Fringer who will attend the College of William and

Mary and to Arielle Dance who is attending Spelman College.

Pamela Read, daughter of the late Robert Read, a former president of the club and member and long-time chairman of the scholarship committee, presented the \$1,500 Linda Read Health Sciences Award to Jeffery Goldstein who will attend D'Youville College, and the \$2,000 Robert Read Law Scholarship to Jessica Graham who is bound for Wake Forest University.

Mrs. Frantz presented the William E. and Chester S. Gerdes Memorial Scholarship, valued at \$3,000, to Jayne Ruotolo who plans to attend Vanderbilt University. Mrs. Frantz awarded two more Wallace Scholarships, valued at \$2,500, to James Arbes, who will attend Rutgers University and to JoAnn Mathew, who will attend Boston College.

Courtney Fox-Sherman received the \$1,500 John J. Foley Scholarship, presented by School Superintendent, Rotarian and former club president, William Foley.

The Emerson Thomas and Jimmy Coventry Scholarships named in honor of two outstanding deceased Rotarians, each valued at \$1,500, were presented by the committee to Eunice Park who will go to Carnegie-Mellon University and to Annie Peyton who will attend Tulane University.
