## B'52's, Everclear to Perform At Two-Day MusicFest '08

CRANFORD—Everclear and The B-52's will be performing at this year's two-day MusicFest '08, September 5 and 6, at Nomahegan Park in Cranford, Union County officials announced on Tuesday.

Everclear will be the headliner for opening night, Friday, September 5, with The B-52's headlining on Saturday, September 6, at Nomahegan Park in Cranford.

Free to the public, the 11th installment of this annual event will feature more than 20 performers, among them a contingent of musical talent from New Jersey on both days.

Last year, a single-day version of MusicFest drew an estimated 50,000 attendees to take in two stages of music. Beyond expanding to two days, this year's event will feature even more musical entertainment on a third stage, a larger version of Kids Kingdom in a new location in the park, additional food vendors, a marketplace, and the return of the Love, Hope, Strength charity walkathon, paired with a newly added 5k race.

MusicFest '08 will officially open Friday, September 5, at 3 p.m. The music will continue on Saturday, September 6, at 8 a.m. to coincide with registration for the Rock On! Walkathon and 5k Rock N' Run. Both nights will close at 10 p.m. Lawn chairs; blankets and picnic baskets are welcome.

Performers will include: Everclear, an alternative rock band, originally formed in Portland, Ore., and known for such hits as "Santa Monica," and "Father of Mine." The Art Alexakis-led group will take the stage at approximately 8 p.m. on September 5.

Cracker, a modern rock group formed by former Camper Van Beethoven frontman David Lowery, known for such hits as "Low," "Teen Angst (What the World Needs Now)" and "Get Off This."

Jenny Owen Youngs, a singer/songwriter from Montclair, who has received national reviews for her debut album, "Batten the Hatches."

Val Emmich, a singer/songwriter and actor hailing from Manalapan. His new album, "Little Daggers," is due to be released September 30. Along with a recurring role on ABC's "Ugly Betty," he has been seen in NBC's "30 Rock" and ABC's "Cashmere Mafia."

Also included will be a host of local acts sponsored by The Crossroads of Garwood - including a solo performance by Smithereens frontman Pat DiNizio of Scotch Plains, Beale Street Love, and Tom Vella, 3rd Party. They will perform on MusicFest '08's newly added Wal-Mart-sponsored third stage.

Helena Maria, a New Jersey born-and-bred duo, will open the main stage. Their music has been featured in MTV's "The Hills" and the upcoming movie, "In My Sleep." Helena Maria also appeared on mtvU's "Meet or Delete: Best Music on Campus" episode.

September 6 musical highlights will include: A headlining set by The B-52's. Known for scores of hits, including "Love Shack," "Rock Lobster," "Private Idaho" and "Roam," the band released "Funplex," its first new studio album in 16 years, in March. The band will close out MusicFest '08.

Tokyo Police Club, a young indie rock band from Toronto that has been featured on MTV, and in *Spin*, *Rolling Stone* and other music publications since the release of their full-length debut, "Elephant Shell," ear-

lier this year. The Gin Blossoms, a power-pop act whose classic 1992 album, "New Miserable Experience" sold three million records thanks to hits, including "Hey Jealousy," "Found Out About You" and "Allison Road."

Rock N' Roll Hall of Famer Felix Cavaliere's Rascals. The voice of one of the biggest groups in the country from 1965-1969 will perform such beloved hits as "Good Lovin'," "Groovin'," "A Girl Like You," "A Beautiful Morning" and "People Got to Be Free."

Dan Zanes, described by *People* magazine as "the crown prince of contemporary kid's music." A Grammy award-winning artist and former member of rock band The Del Fuegos, Zanes and his band are regularly seen and heard on PBS' "Sesame Street" and "Playhouse Disney."

Mike Peters with the New Jersey Symphony Orchestra Chamber Players.

The founder and lead singer of The Alarm will return to MusicFest without his band for a very solo performance of his songs with orchestral accompaniment.

Glen Burtnik and Friends performing a set of classics from The Beatles catalog. Based in New Brunswick, Mr. Burtnik is a singer, guitarist and songwriter. A one-time member of Styx, he is also known for his portrayal of Paul McCartney in the original Broadway production of *Beatlemania*.

Danielia Cotton, a blues rock artist from Hopewell, who has released three studio albums, including the recently released "Rare Child." Cotton and her band have toured with artists, including Gregg Allman, Flaming Lips, Buddy Guy and fellow New Jerseyans Bon Jovi.

Several local acts - including Jobananno and the Godsons of Soul featuring Vini Lopez and Roadside Graves - will perform on MusicFest '08's newly added Wal-Mart-sponsored third stage.

Additionally, MusicFest '08 will feature several performances by The What Cheer? Brigade, a 19-piece rowing brass band from Providence, R.I., across both days.

Other attractions will include: The John Lennon Educational Tour Bus, a state-of-the-art mobile audio and video recording studio, and an educational vehicle will deliver a hands-on musical experience for MusicFest '08 attendees.

The Major League Baseball Traveling Road Show, which includes pitching and batting cages and video game kiosks, an attraction at last year's event and will return to the MusicFest grounds in 2008.

The Marketplace, expanded for MusicFest '08, will add a variety of vendors and a host of new food merchants.

As previously announced, the Rock On! Walkathon and 5k Rock N' Run (on a certified USATF course) will open the festival on Saturday, September 6 (7:30 a.m. registration, 9 a.m. run start, 9:15 a.m. walk start) to benefit the Love Hope Strength Foundation ([lovehopestrength.org](http://lovehopestrength.org)) and The Valerie Fund ([thevaleriefund.org](http://thevaleriefund.org)).

September 6 events will include the Kids Kingdom Traveling Jubilee, an entertainment show featuring rides and amusements for children, which will be staged in an expanded area at Shane Walsh Field, which adjoins Nomahegan Park.

The Shane Walsh Field area will also include a stage for family acts, a petting zoo for children, and arts and crafts.

A laser tag area for adults and children will also be located in the Shane Walsh Field area. A height of 52-inches is required to participate.

In the event of rain, MusicFest will be held at Kean University, however, the Rock On! Walkathon and 5K Rock N' Run will be held in Cranford. Sponsors include Overlook Hospital (presenting sponsor), The Hartford, Elizabethtown Gas, Wal-Mart, Anheuser-Busch, Kean University, Commerce Bank, Verizon, Caesars, Rio22 and others.

The Holiday Inn on Route 22 in Springfield will again provide discounted room rates for MusicFest attendees.

## State Nonprofits to Share In Federal Homeland Grants

HAMILTON—Thirteen nonprofit schools, hospitals and religious organizations will share nearly \$835,000 in federal grant funds to improve their security, New Jersey Office of Homeland Security and Preparedness (OHSP) Director Richard Cañas announced July 31.

Mr. Cañas said all of the 13 recipients of the 2008 Nonprofit Security Grant Program funds from the U.S. Department of Homeland Security (DHS) are located in the seven counties covered by New Jersey's Urban Area Security Initiative (UASI) program. Nationwide, DHS allotted \$15 million for this program and made awards to a total of 232 agencies and organizations. New Jersey's UASI received the sixth highest nonprofit grant total in the country, after UASI programs from New York City, California's Los Angeles, Long Beach and Bay areas, Chicago and Baltimore.

"We're pleased that DHS has made these funds available again this year," Mr. Cañas said. "Awarding federal funding to nonprofit organizations to improve security measures at their facilities is an important part of New Jersey's homeland security strategy,

and will support our overall security efforts."

The grant criteria, established by DHS, included whether the eligible organizations maintained a site with symbolic value and are a recognized national or historical institution that makes it an attractive target.

It was also considered if the organizations had a role in responding to or recovering from a terrorist attack or had potential vulnerabilities to attack, especially if documented by a prior risk assessment.

Mr. Cañas said the grant funds must be used for "target hardening" activities, such as the purchase and installation of physical security equipment or for security-related training for organization personnel. The grants require the organizations to provide a 25 percent cash match or the equivalent in related training.

Since 2003, New Jersey's UASI, which covers Bergen, Essex, Hudson, Middlesex, Morris, Passaic and Union counties, has received more than \$168.6 million in federal funds to protect the state's densely populated Northeast region.

Among those non-profits receiving funding were: Essex County's JCC MetroWest \$75,000; Solomon Schechter Day School of Essex and Union Counties, \$15,000; Liberty Science Center, Jersey City, \$75,000; Morristown Memorial Hospital/AHS Corp., \$75,000; Rabbinical College of America in Morris County, \$62,118; St. Joseph's Regional Medical Center in Paterson, \$75,000, and the Jewish Educational Center in Elizabeth, \$75,000.

## Pedestrian, Bike Fatalities Show 9 Percent Decline

AREA—"Skipping on Sidewalks 2008," a new report released by the Tri-State Transportation Campaign, documents a slight decline in pedestrian and bicyclist fatalities from 2006 to 2007, but warns that sustained progress has yet to be made.

"The inability to meet long-term pedestrian and bicyclist safety goals overshadows 2007's good news," said Kate Slevin, executive director of the Tri-State Transportation Campaign.

In 2007, 162 pedestrians and cyclists were killed in New Jersey, a 9 percent decline from the previous year. But the state is far from achieving a 1998 goal set by Governor Christine Whitman to halve the number of pedestrian fatalities from the 145 killed in 1997 by 2010.

According to the report, eight pedestrians and one cyclist were killed in Union County in 2007, representing 20 percent of all Union County's traffic fatalities for the year.

The county had 20 pedestrian fatalities in both 2000 and 2001, 19 in 2002, 11 in 2003, 22 in 2004, 12 in 2005, and 13 in 2006, according to New Jersey State Police statistics released.

### Shining STARS Take The Stage in Grease

SCOTCH PLAINS - Students Thespians are Recreating the Stage (S.T.A.R.S.) will perform the musical *Grease* on Friday and Saturday, August 8 and 9, at 7:30 p.m. on the Scotch Plains Village Green stage.

S.T.A.R.S. is a summer theater group made up of local students and supported by the Scotch Plains Department of Recreation. Admission is free to everyone.

Following a high number of fatalities along Route 22, Union County initiated a pedestrian shuttle along the highway.

Within the state, Middlesex, Essex and Bergen counties were the most dangerous places to walk or bicycle, with 19, 18 and 15 fatalities, respectively, in 2007. Hudson, Bergen, Essex and Passaic counties had the highest share of total traffic fatalities who were pedestrians or cyclists.

The report also found that interest in walking has increased since 2000. The campaign's analysis finds that New Jersey seniors are especially at risk of being killed as a pedestrian and are killed at rates that exceed the rest of the country. Older New Jersey residents are more than twice as likely to be killed as a pedestrian than members of the population as a whole, according to the report. The state-wide pedestrian fatality rate is 1.79 per 100,000 persons. But for New Jersey residents aged 65 and older, the fatality rate is 3.72 - and the rate is 4.62 for those aged 75 and older.

"Creating safer places for older New Jersey residents to walk will become increasingly important as the state's population ages," said Kate Slevin, executive director of the Tri-State Transportation Campaign. "Simple changes like longer crossing times would go a long way toward making it safer and easier for older residents to get around."

The report says the state should implement more policies like the five-year, \$74-million initiative begun in 2006 that targets funding to bicycle and pedestrian projects.

The campaign recommends three strategies to reduce pedestrian and cyclist deaths and better target funding:

Use the next reauthorization of the Transportation Trust Fund as an opportunity to increase funding for New Jersey Department of Transportation pedestrian and bicycle programs.

Develop a new "Safe Streets for Seniors" funding program aimed at improving pedestrian safety in places with high numbers of older adults.

Target bicycle and pedestrian funding to places with the highest number of pedestrian and bicyclist injuries and deaths.
