Watchdog Asks AG If Mirabella Agreement Was Act of 'Favoritism'

Editor's Note: The following letter includes excerpts from a letter sent to state Attorney General (AG) Paula Dow. Through a series of Open Public Records Act (OPRA) requests it has come to our attention that the Borough of Garwood (GW) signed an agreement with Officer Genarro Mirabella that stipulates he would resign in exchange for having two disciplinary actions dismissed. A request to the state's AG was made for an investigation into whether favoritism or other improper purpose influenced any officials involved.
