
## Raymond J. Lawrence, 92, Had Been U.S. Marine, Westfield Police Officer



SECTION VIII. In the event that any section, part of provision of this ordinance shall be held to be unenforceable or invalid by any court, such holding shall not affect the validity of this ordinance as a whole, or any part thereof, other than the part so held unenforceable or invalid.
