How can we continue to trust our lives and fortunes to people claiming to know what they are doing when they do not know what they are doing?

President Hoover, inaugural address, March 4,1929, "The larger purpose of our economic thought should be to establish more firmly stability and security of business and employment and thereby remove poverty still further from our borders." But the Great Depression was right around the corner.

FDR, accepting the 1932 Democratic nomination for president, "I pledge myself to a new deal for the American people" to end the Great Depression. But unemployment remained high until the Second World War.

British Prime Minister Neville Chamberlain, September 30,1938, declared that the Munich Agreement would mean "peace in our time." But the Second World War began less than a year later.

President Truman's strategy produced stalemate, not victory, in Korea. Defense Secretary Robert McNamara in his 1964 Senate testi-

mony, "I must say I don't object its being called McNamara's War. I think it a very important war and I am pleased to be identified with it and do whatever I can to win it." But North Korea defeated South Korea despite the enormous loss of American lives and the vast expenditure of other national treasure!

President George W. Bush in the Azores, March 16, 2003, "The dictator of Iraq and his weapons of mass destruction are a threat to the security of free nations." But the Central Intelligence Agency's Iraq Survey Group later concluded after an exhaustive 15-month investigation that Saddam Hussein did not have chemical, biological, or nuclear weapons or any program to create them.

President Obama on September 14, 2013 welcomed the Russo-American protocol to eliminate Syrian chemical weapons that followed a Syrian government chemical weapons attack in Damascus on August 21, 2013. But chemical attacks have continued!

President Obama repeatedly declared about the Patient Protection and Affordable Care Act, "If you like your health care plan you can keep it." But millions of Americans have lost their health care plans.

There are mistakes and there are mistakes. No real harm was done to anyone because that famous tower in Pisa was built on unstable soil.

Indeed some mistakes turn out well! Alexander Fleming discovered penicillin in a contaminated Petri dish. John and Will Kellogg invented corn flakes when they rolled some stale wheat through rollers. Chemist Constantin Fahlberg discovered Saccharin by connecting the sweetness on his unwashed hands covered with the anhydroorthosulphaminebenzoic acid with which he had been working. Eleven-year-old-year old Francis Epperson invented the Popsicle when he left his flavored water drink with the mixing stick in it on his back porch where it froze during the night. French scientist Eduard Benedictus discovered safety glass when the glass flask containing cellulose nitrate a liquid plastic he had accidentally dropped did not shatter.

But mistakes about domestic policy cannot be tolerated, nor can mistakes about war in the thermonuclear age when one mistake may be one too
