They began this project in early Spring of this year. Members of the group knitted and crocheted each item using their own unique patterns. The bulk of the yarn used for this project was from donations received from people in and near the community.

The women were shown a testimonial video of participants in the mission and listened to one young man's difficult experience of homelessness and drug addiction before entering the mission. Mission staff members Phil Parsels, development director; Susan Bosworth, development manager, and Jacob Michael Gaeta, assistant resident director, were on hand to receive the donations and acquaint the seniors with the history of the Market Street Mission and its day-today operations.

"For more than 129 years, the Mar-

ket Street Mission has been a haven for the needy. Since the Mission's foundation in 1889, they have been changing lives and helping people live responsibly and productively. The goal of the Market Street Mission, located in Morristown, N.J., is to help men, women and children in need through their Emergency Assistance program and their Rehabilitation and Recovery program," according to Mr. Parsels.

Imagine Seeks Individuals For Training as Volunteers

MOUNTAINSIDE — Imagine, A Center for Coping with Loss is seeking 10 individuals for its upcoming volunteer facilitator training session. The session will take place Friday through Monday, October 19 to 22, from 9 a.m. to 5 p.m. daily.

Imagine peer support groups serve grieving children and families in Union County and beyond. Groups are facilitated by trained adult volunteers who attend a 32-hour training program and quarterly continuing education programs.

Volunteers come from all walks of life and need no special background other than a willingness to listen and the ability to be with children and adults in pain without trying to fix, solve problems, or give advice. No prior experience is necessary. Volunteers must be age 21 or older. They serve as companions and loving listeners for those who are grieving.

"As our programs continue to grow, so does our need for additional, highlytrained facilitators," said Mandi Zucker, Imagine program director.
