JEN CALABRESE ZINGS IN 14 POINTS Hornet Hoopsters Sting Lady Highlanders, 38-32

The fifth-seeded, 15-9 Governor Livingston High School girls basketball team ended their dream for a North Jersey, Section 2, Group 2 sectional championship by losing to second seeded, 20-4 Hanover Park, 38-32, in the finals on March 7 at Rahway High School. Senior Jen Calabrese scored 14 points for the Highlanders.

Prior to tip-off, Governor Livingston coach Dan Kopcha commented, "The kids played super the last two games, so this evening it gives them yet another kind of challenge. We know very little of this Hanover Park team, but we did hear they have a good ball player in center Aja Parham underneath. So it will be a kind of see and find out what they have early on and how we respond."

The Hornets stung early, scoring six unanswered points on the unsettled rather nervous G.L. starting five and buzzed to a 13-6 first-quarter lead. However, after missing their first seven shots, G.L.'s Calabrese led a furious charge in the second quarter to squish the Hornet's lead to one.

The G.L. defense led by senior Maya Monroe, sophomores Margie Goodspeed, Becky Ringwood, Peggy Lallis and Meghan Butler, junior Katie Dotto and Calabrese sacrificed their bodies to the hardwood floor, created steals and made crucial blocks. Additionally, they held Hanover's Parham to three points as both teams headed to the locker room with Park leading, 22-21.

The turnout of more than 300 Highlander fans went into a frenzy in the third period as Monroe appeared possessed, blocking shot after shot while Calabrese retaliated with five consecutive points for a 7-1 run to give the Highlanders a 28-25 lead.

In the fourth quarter, Hanover's Parham demonstrated her stardom, spearheading the offense with five-straight points, while defensively corralling four rebounds and three steals. Parham then focused on teammate guard Jen Detroico at the top of the key for a three-point bomb, giving Hanover the lead, 35-33, with 2:28 remaining.

The Lady Highlanders suddenly found themselves in a panic situation and, lost their focus with 1:34 left, turning the ball over and missing two free throws to end an emotional, well-played basketball game.

Monroe finished with nine points and Goodspeed and Dotto both had six.

"I thought we played well as a team," said Monroe, "We found it difficult to defend Parham, she's just an excellent all-around player. Now that it's all over, I'm really going to miss my fellow players. They are talented as well as the most wonderful group of girls anyone could ever have the pleasure of associating with."

Having played her final high school game, Calabrese said, "I just had a lot of fun playing this game. I will miss the game, my teammates and the student body who came out to support us."
