John Henry Flood Makes All American in Lacrosse

John Henry Flood of Westfield was named High School All American in boys lacrosse by the New Jersey Inter-scholastic Coaches Association (NJILCA). Fifteen boys were voted in as New Jersey All Americans by the lacrosse coaches throughout New Jersey. There are approximately 200 High School All Americans named in lacrosse in the United States each year. Each state is given a number that can be named based on the number of participating high school lacrosse programs in that state.

Flood graduated from The Lawrenceville School in Lawrenceville on June 1. He received one of the school's top awards at graduation called the Elizabeth Gray Award for the student who gives as much back to The Lawrenceville Community as he takes from it.

Flood will be attending Harvard University after taking a year off to play lacrosse in Australia. He was named to the first team all state "A"

division by the NJILCA as well as the Prep Player of the Year by *The Star Ledger*. Flood started his lacrosse career in the Westfield youth lacrosse program and played from 3rd through 8th grade with Westfield.

Other Westfield residents named to the NJILCA All State teams are: Second Team All-State A Division, Bill Schultz, Mike DeBrossey and Dan McDonald (play for Westfield High School); Honorable Mention All-State A Division, Kevin Riley (plays for the Lawrenceville School).
