## JOSH WEXLER SCORES LONE RAIDER RUN IN 4TH Piscataway Chiefs 'No-Hit' Raider Baseballers, Win 11-1

Playing a non-conference game against a tough Piscataway High School team and without the services of senior Tri-Captains Dave Baumwoll and Andrew Pavoni, Scotch Plains-Fanwood High School baseball Head Coach Brian Homm decided to give some of his younger pitchers some experience. What was experienced was an 11-1, five-inning, no-hit shutout at the hands of the Chiefs in Scotch Plains on April 26.

The Chiefs put the young Raiders in a hole quickly with seven runs in the top of the first inning. Raider starter, Steve Horn may have thought that things were going to be fine when Chief leadoff batter Eric Young tapped a grounder to short. Unfortunately, the throw to first was bad and Young glided to second. Young advanced to third on a passed ball, then scored on a sacrifice fly to right.

Instead of having the first two batters out, one run was in and there was only one out. From that point, Horn proceeded to yield the first of 13 Raider free passes. Five singles, including three straight, and three walks later, the Chiefs had the Raiders in a 7-0 hole.

"Horn looked pretty good the last couple of times he came in relief, so I figured I would give him a shot," explained Coach Homm. "But they scored seven quick runs so I went with Baker and D'Annunzio. You can't

win ball games when you walk 13 guys. It was a little disappointing pitching today. Even though some of the younger kids came in to pitch, they have to throw strikes."

The closest the Raiders came to getting a base hit was in the bottom of the inning when Josh Wexler punched
