visibly upset and shaken. Melissa volunteered to follow the family home to make sure everyone was alright. She also fixed dinner for the children and got them ready for bed, before driving home to Pennsylvania. She then got up the next morning to attend classes at Kean University.

Westfield Foundation Lists Grants For Fourth Quarter

WESTFIELD - The Trustees of the Westfield Foundation recently approved \$44,500 in grants for the fourth quarter of 2002 to support area agencies and programs.

The Youth & Family Counseling Service received \$5,000 to support a counseling program at the Westfield Community Center addressing coping skills for adolescents.

A grant of \$4,000 has been awarded to the Cerebral Palsy League to purchase furniture and play equipment needed for expansion of the Come Play and Learn Early Childhood Center, the only dual licensed pediatric medical day care center in the state.

The Greater Plainfield Habitat For Humanity, which operates solely on a volunteer basis, received a grant of \$2,500 for construction materials and property to continue the organization's work in 2003. To date, 22 homes have been built by volunteers and partner families.

WYACT (Westfield Young Artists' Cooperative Theatre) was awarded \$5,000 to help defray the costs of its 2003 summer productions. The program enables Westfield youngsters, as well as other emerging talent from across New Jersey, to participate in youth-theatre full scale productions free of charge.

A grant of \$4,000 was awarded to NJ KidPower, an international organization which provides programs emphasizing positive prevention education. The monies will be used for personal safety skills workshops in Westfield schools.

The Westfield Cultural Arts Center is an organization whose purpose is to create and operate a community arts and history center that would offer year-round artistic, cul-

tural and history-related activities for local and area residents. The Trustees awarded \$15,000 to fund a preliminary schematic design and cost estimate for a cultural arts center in Westfield.

The Westfield Bach Festival received a grant of \$5,000 in support of a three-day Bach Festival to be held in February of 2003.

An award of \$4,000 was granted to the Westfield Chamber of Commerce to expand the Holiday Lights Program to the South Avenue and Central Avenue business districts.


