SELINGROVE, PA. - Sophomore Sophie Hall of Westfield (WHS) was a member of the Susquehanna University volleyball team that finished its 2005 season with a 20-16 overall record and a 2-5 record in Commonwealth Conference play under third-year head coach John Tom.

Hall played in 125 games over 35 matches and finished the season with 44 kills, 214 digs, 27 blocks, 58 aces and 1,257 assists. For her career, Hall has recorded 101 kills, 306 digs, 53 blocks, 91 aces and 2,492 assists.

STROUDSBURG, Pa. - The University of Scranton swim team suffered its first loss of the season by dropping a 108-97 decision to East Stroudsburg University in non-conference action on November 8.

Freshman Erin O'Connor of Scotch Plains/Union Catholic touched first in the 200 individual medley with a time of 2:16.75. Sophomore Danielle Heffernan of Westfield finished second in the 100 free with a time of 0:56.91.

O'Connor won the 200 individual medley with a time of 2:18.29 and the 500 freestyle at 5:28.81 to spark Scranton past Dickinson College, 113-87, in non-conference action on November 12. O'Connor swam the final leg on the 400 medley relay team as the Royals placed first and second in the event to jump out to an early 15-2 lead. Junior Jill Palmiotto (Brookfield, Conn./Brookfield), sophomore Gina Miller (Secane, Pa./Cardinal O'Hara), senior Erin Williams (Emmaus, Pa./Emmaus) and O'Connor covered the distance in 4:13.43.
