NOTICE IS HEREBY GIVEN, pursuant to N.J.A.C. 5:30-11.9(c)(6), that a Resolution was adopted by the Township Council of the Township of Scotch Plains on November 8, 2006 confirming actions relating to change orders for work at the South Side Firehouse Addition and Replacement Communications Tower and that an Ordinance to appropriate funds for such change orders was adopted on May 2, 2006.

The additional amount to be expended is \$174,075.00. The original contract price was \$484,900.00.

The nature of the work to be done was the construction of a replacement communications tower at the South Side Firehouse and necessary additions to the South Side Firehouse. It is necessary to expand the additional funds for the following reasons:

During the course of the work on the project, there were changes in the work which, at the time of the Contract award could not have been reasonably foreseen, and said changes to the scope of the Contract were as follows:

A. The discovery, during drilling, of unanticipated solid sub-surface rock which required substantial additional time and cost and which could not have been reasonably foreseen;

B. The refusal by PSE&G to accept the electrical system designed and specified in the Bid Documents by the consultant engineer, which required substantial additional work and costs and which could not have been reasonably foreseen;

C. The drilling of additional ports in the cell tower after its installation based on the fact and required because one telecommunications carrier did not submit a bid for rental of space on the pole until after the Contract award to the general contractor and because the other telecommunications carriers advised the general contractor of different requirements for cell tower ports after the pole was fabricated and installed, all of which could not have been foreseen.

D. The elimination of utility hook-ups within the fifth room of the building addition which were found to be unnecessary.

E. The elimination of outdoor shrubbery which will be redesigned and installed by the Township at a later date.
