

Union County College Posts President's List for Fall

CRANFORD – Of the approximate 11,000 full-time and part-time credit students who attended Union County College (UCC) during the fall 2005 semester, 244 students have been named to the President's List in recognition of their academic excellence.

To qualify, a student carrying at least 15 credits for a semester must achieve a minimum 3.50 grade point average out of a possible 4, with every grade being a "B" or higher. A matriculated student carrying 12 credits during one semester is eligible for the President's List if he or she achieves a GPA of 3.75 or better, with no grade lower than "B." A part-time matriculated student will be considered if he or she has earned at least 12 credits and has attained a cumulative grade point average of at least 3.0. Once this minimum is met, the student must carry no less than six credits and attain a semester average 3.75 with no grade lower than a "B."
