AN ORDINANCE PROVIDING FOR THE INSTALLATION AND OPERATION OF TRAFFIC CONTROL SIGNAL AT VARIOUS LOCATIONS
BE IT ORDAINED by the Town Council of the Town of Westfield in the County of Union:
SECTION I. That a traffic control signal shall be installed and operated at the intersection of the following locations:
 East Broad Street and Elm Street
 Elm Street and Dudley Avenue
 Central Avenue and Clifton Street
 Central Avenue and Grove Street
 North Avenue and Central Avenue
 Central Avenue and South Avenue
 Central Avenue and East Broad Street
 East Broad Street and Mountain Avenue
 East Broad Street and Euclid Avenue
 East Broad Street and Springfield Avenue
 Springfield Avenue and Mill Lane
 Springfield Avenue and Cardinal Drive
 South Avenue and Summit Avenue
 South Avenue and Westfield Avenue
 Central Avenue and Park Street
 North Avenue and Elm Street
 South Avenue and West Broad Street
 South Avenue and Crossway Place
 North Avenue and East Broad Street (The Plaza)
SECTION II. That the traffic signal installation shall be in accordance with the provisions of an act concerning motor vehicles and traffic regulations, Sub-title 1 of Title 39 of the Revised Statutes; shall conform to the design and shall be maintained in operation, as authorized by the Department of Transportation.


