**Dan Siegel Defends WTA Men's Singles Tourney Title**

Dan Siegel bested Robert Errazo in the Westfield Tennis Association's sixth annual Men's Singles Tournament, featuring 15 players, on May 5 and 6 at Tamaques Park courts. Siegel won the first set, 7-5, but Errazo roared back, 6-3, in the second. Siegel won the third set, 6-1.

Siegel had beaten Weldon Chin 8-5 in the semifinals and Chris Blaise,

8-3, in the quarters. Errazo bested Pete Magierski in the semis, 8-3. Azim Saifee, 8-5, in the quarters and Tuyen Diep in the first round.

Magierski placed third with an 8-3 victory over Chin. In the first rounds, Magierski bested Joshua Suri, 8-2, and Tom Bigosinski, 8-4. Chin finished fourth with earlier, 8-5 victories over Henry Williams and

Andy Herz.

Diep, after playing a tough match with Errazo, won the "B" bracket championships with wins over Herz and Blaise, and a come-from-behind, 1-6, 7-6 and 7-5 three set victory over Saifee. Saifee won his first match with John Mancini, then after losing to Errazo in the quarters, bested Alex Winniker and Bigosinski, 6-1, to reach

the "B" finals. Bigosinski and Blaise will play to decide third place in the "B" bracket.

NOTICE is hereby given that on Wednesday, May 23, 2007, at 7:30 P.M. in the lower level meeting room of Borough Hall of the Borough of Fanwood at 75 North Martine Avenue, Fanwood, New Jersey, the Fanwood Planning Board will hold a public hearing for major subdivision approval for Woodcliff, Inc., 7 Beverly Avenue, Fanwood, New Jersey, also known as Block 4, Lot 7. This application seeks approval to convert 1 lot into 4 building lots plus one lot for a detention basin. B. Section 184-110 E (2) Lot Width - The R-75 District requires lots to be 75 feet in width. Widths less than seventy five (75) feet are proposed for Lots 7.01 and 7.04. One or both of these variances may have been rendered moot as a result of the previous hearing.

C. Section 184-132 Flag Lot - If the proposed detention basin lot is deemed a flag lot, a variance would be requested including variances for lot frontage and lot width.

The applicant will also seek such other variances and relief as may be determined necessary at the public hearing based upon review of the application or amendment(s) to the application.

Any interested party may appear at said hearing and participate therein in accordance with the rules of the Fanwood Planning Board.
