**State GOP Aims to Provide** NJ With a 'Choice for Change' New Jersey State Republicans, the

minority party since 2002, will run on a platform of providing New Jersey voters with "The Choice for Change."

Included in the platform are initiatives that would cut the state budget by \$1 billion, oppose any new tax increases, cap spending increases at the rate of inflation and enact reforms that would ban pay-to-play and suspend indicted public officials without pay.

The platform also proposes requiring two-thirds of the legislature to approve new taxes or increases in existing taxes, voter approval for all future state debt, creating a new schoolaid formula that is "fair and equitable" for all districts and making it easier for voters to recall elected officials.

Corzine Names Hudson's Doria **Commissioner Of Comm. Affairs** 

Governor Jon Corzine has appointed State Senator Joseph Doria of Hudson County as director of community affairs. Mr. Doria, who is not seeking reelection, served 24 years in the assembly, according to nj.com. He will resign as mayor of Bayonne when he takes his new office on October 9.

Sandra Cunningham, the Democratic senate candidate and wife of the late Jersey City Mayor and Senator Glenn Cunningham, will likely replace him.

**Seton Hall Pulls Plug on Talk** By Tom DeLay Before GOP Club

Seton Hall University has denied a request by the College Republicans to have former House Majority Leader Tom DeLay speak on the South Orange campus. The university spokeswoman said, "The university felt the legal and ethical questions surrounding him did not make him an ideal choice to speak on campus at this time."

College Republicans President Christopher Stark called Seton Hall's actions "unconscionable," noting that four years ago, the university invited the former president of Iran as a guest, "a man who began the nuclear weapons program and had documented human-rights violations - yet Tom Delay is clearly more controversial and less intellectually in tune with

**Merkt Wants Singh to Quit** 

**Race Over Pension Abuse** Assemblyman Richard Merkt, a Republican from Morris County, said he wants State Senate candidate Seema Singh to drop her bid for the 14th district seat (Mercer County) after her involvement in what Mr. Merkt called "possible public pension abuse," ac-

cording to Politicsnj.com. This follows a Trenton Times report that Ms. Singh, the former state public advocate, had hired her former chief of staff, Leora Mosstown, as a \$125-per-hour consultant after her ex-staffer had retired. State officials ordered Mosstown to pay back \$86,000 in pension funds.

Guttenberg Mayor, Wife **Arrested for Fraud, Extortion** Guttenberg Mayor David Delle Donna and his wife, Anna, were indicted last week on charges of mail fraud and extor-

tion, according to politicsnj.com. Authorities said Delle Donna allegedly took bribes from an unnamed local bar owner in the form of thousands of dollars in tickets to campaign events in exchange for helping the bar get approved for a variance and to rid itself of property violations the town cited.

#### New Jersey Sues Bush Over Children's Health Fund

Governor Jon Corzine announced Monday that the state has filed a lawsuit against the Bush Administration for limiting eligibility for the State Children's Health Insurance Program (SCHIP). The suit says 10,000 New Jersey children would be affected by the new eligibility rules, according to a press release on the New Jersey State Democratic Committee website.

The President said in a White House statement that the Congressional bill he vetoed would raise spending from \$35 to \$50 billion and turn a program aimed at poor children into one with family incomes of \$83,000 and pull kids currently covered by private health insurance into a government-run system.

### MEET THE CANDIDATES

James M. Foerst for Reelection, Westfield Town Council, Ward 4

As a father, husband, homeowner and businessman, I fully understand the importance of careful budgeting and spendng. While only \$1 in every \$6 of your tax bill is allocated to the town (21 percent is allocated to Union County and 62 percent to the board of education), I work hard to stretch these limited funds while continuing to provide top quality services that exemplify Westfield

One of the town's largest expenses is salaries and wages. Through prudent, yet fair, collective bargaining with our union employees, we have been able to save money. By working with the unions, we negotiated health-insurance-plan changes, which yield premium increases below 5 percent (state average increases for public entities were approximately 12 percent). This is a savings of more than \$280,000 in 2007 alone, and these savings were similar in 2006. Our employees continue to earn fair salaries and benefits, and we save hundreds of thousands of

dollars each year. Also, over the last four years, I have worked to save you money by reducing the number of town employees. As an example, when I was first elected to council, we had one full-time employee in our TV-36 television department. Through attrition, we eliminated this full-time position and brought in a more experienced, part-time employee, saving more than \$25,000 annually. However, we did not compromise quality of services to achieve this savings. On the contrary, every time

you turn on TV-36, you see the improved variety of programming, enhanced visual clarity and greater capacity to disseminate important information.

Finally, we have been very aggressive and effective in seeking grants of varying size, use and nature that are available to the town. For example, we obtained more than \$200,000 of grant money to fund operations and equipment upgrades in our police and fire departments and more than \$160,000 for improvements of our parks and fields. Also, this year, we secured \$36,000 from the Safe Routes to Schools program to fund plans and improvements that otherwise would have required funding through your taxes.

These measures have the net effect of saving money for each and every property taxpaying household in Westfield. These are only a few of the examples of ways, which I have worked and will continue to work to save money and keep your taxes in check. I will continue to view every dollar in the budget as my own and work hard to find new ways to save money and obtain additional local, state, federal and private aid to fund many of the improvements that we have and will continue to make to our infrastructure.

It has been my honor to serve the people of the Fourth Ward for the last four years. I hope that you have seen and felt the improvements we have made and will allow me to continue to serve as your councilman by supporting me on Elec-
