**RWJ Receives \$15 K
Gift for Cardiac Lab**

RAHWAY — ConocoPhillips
Bayway Refinery has donated
\$15,000 to the Cardiac Catheteriza-
tion Lab Replacement Project at Rob-
ert Wood Johnson University Hospi-
tal at Rahway.
According to Marlene Lubinger,
president of the RWJ Rahway Foun-
dation, almost one third of the people
living in the hospital's service area
are 65 or older and that population is
growing as the baby boomers age.
Last year 62 percent of all patients
admitted to the hospital were 65 and
over and more than half had a car-
diac-related diagnosis. In addition,
more than half of all patients admit-
ted to the emergency center have a
cardiac-related diagnosis.
"Understanding the need to pro-
vide cardiac cath in a nearby and
familiar setting for our patients and
their families, the hospital renovated
and replaced the outdated Cardiac
Cath Lab with a state-of-the-art Cath
Lab," Ms. Lubinger said. The new name
of the lab is The Cardiovascular
Lab at RWJ Rahway.

**GENERAL ORDINANCE NO. 1985
AN ORDINANCE TO AMEND
THE CODE OF THE TOWN OF
WESTFIELD, CHAPTER 20**

BE IT ORDAINED by the Town Council of the Town of Westfield in the County of Union as follows:
SECTION 1.
That the provisions of Section 20-20 are hereby repealed and replaced with the following Article III (Sewer User Fees), consisting of Sections 20-23 through Section 20-25:
20-23. There shall be a sewer user fee for each property for the period May 1, 2012 through December 31, 2012 based on the uses of the property as classified on the Tax List District Summary in accordance with the following schedule:
(a) Residential uses (Class 2). The sewer user fee for Class 2 Residential units consisting of single-family and multi-family residential units, except for condominiums and townhouses, shall be \$170.00 per annum. The sewer user fee for a Residential unit, which consists of a condominium or townhouse, shall be \$135.00 per unit.
(b) Commercial and industrial uses (Classes 4A and 4B). The sewer user fee for Classes 4A and 4B properties shall be \$315.00.
(c) Apartments (Class 4C). The sewer user fee for each apartment unit in a Class 4C property shall be \$100.00.
20-24. Owners of all properties who are senior citizens or permanently and totally disabled persons and who qualify for a senior citizen or disabled person tax deduction pursuant to the provisions of N.J.S.A. 54:4-8.40 et seq., shall receive a deduction of \$25.00 from their fee.
20-25. The bill for the sewer user fee shall be forwarded by the Town to the property owner, or other party designated in writing by the property owner, on or before May 15, 2012 and shall be due no later than July 1, 2012. There shall be a ten (10) day grace period from the due date. Sewer user fees shall be a lien upon the property until paid, and the Town shall have the right to exercise the same remedies it has for the collection of taxes upon real estate with interest, cost and penalties as provided in N.J.S.A. 54:4-67.
SECTION II. All ordinances or parts of ordinances, including all provisions contained in Chapter 20, in conflict or inconsistent with any part of the terms of this ordinance are hereby repealed to the extent that they are in such conflict or inconsistent.
SECTION III. In the event any section, part or provision of this ordinance shall be held unconstitutional or invalid by any court, such holding shall not affect the validity of this ordinance as a whole, or any part thereof, other than the part so held unconstitutional or invalid.
SECTION IV. This ordinance shall take effect after passage and publication, as soon as, and in the manner permitted by law.
