Leader Editorial on BridgeGate Overlooks A Watergate Nightmare
 I read with concern your editorial in your January 23 edition which urges a limit on the inquiry into Bridgegate to an investigation by the U.S. Attorney. Your suggestion overlooks the limits on powers of the separate branches of government.
 An investigation by the U.S. Attorney, by law, is limited to a determination whether any crimes have been committed. By contrast, a legislative inquiry, as the New Jersey Legislature is undertaking, determines whether laws are necessary to prohibit such conduct in the future, including the enactment of criminal laws. Watergate provided an excellent example for the need of investigation by two branches of the government. Without a legislative inquiry, the abuses of power by the executive would have continued unchecked, as the Congressional investigation uncovered extraordinary acts and procedures by that administration which would not have been disclosed by the U.S. Attorney's investigation.

Fishman Investigation Should Be Thorough Without Politics

In this space on February 19, 2009 we questioned President Obama's appointment of Paul Fishman as United States Attorney for the District of New Jersey because he had represented Carla Katz, then president of the Communication Workers of America and girlfriend of then Governor Jon Corzine.
 We questioned why a defense attorney was being proposed for the position of federal prosecutor, particularly one with ties to Ms. Katz's and Mr. Corzine's affairs.
 U.S. attorney now for five years, Mr. Fishman currently is conducting an investigation into whether any federal laws were broken by members of Governor Chris Christie's administration in relation to the closing of lanes in Fort Lee to the George Washington Bridge. The Governor fired his deputy chief of staff, Bridget Anne Kelly, and pulled his appointment of Bill Stepien, his former campaign manager, to be the new chairman of the New Jersey Republican Committee over this scandal. Two others quit their positions with the Port Authority of New York and New Jersey over Bridgegate.
 We believe as a federal prosecutor, it is Mr. Fishman's job to conduct a thorough investigation into the Fort Lee controversy as well as that of charges by Hoboken Mayor Dawn Zimmer that the administration had cut Sandy relief funds to her city over her lack of support for a development supported by the Christie administration. The city has received \$70 million in funds, and received \$142,000 in state-federal Hazard Mitigation Grant Program (HMGP) funds. The administration has denied Mayor

Zimmer's allegations.
 With these two investigations becoming national news, we believe a federal prosecutor - Mr. Fishman - is best suited to conduct this investigation, not the State Legislature or politicians in Washington, D.C.
 The Assembly Transportation Committee probe is headed by Assemblyman John Wisniewski, the former chair of the state's Democratic Committee. Is his intent to be unbiased or just to destroy the Governor and any chance he has for competing with Hillary for President?
 The Port Authority and Bergen County Prosecutor's Office also are launching their own probes. The State Senate joined the Assembly this week in a joint investigation.
 We hope Mr. Fishman will let the facts decide this investigation, and not let his boss at the White House or state Democrats influence his report.
 Are Democrats only looking to impeach the Governor? After all, they just hired Reid Schar, a former assistant U.S. attorney who prosecuted former Illinois Governor Rod Blagojevich for trying to sell the President's former U. S. senate seat to the highest bidder.
 Who's running the state now and who's doing the people's business?
 In 2009 after our editorial was published regarding Mr. Fishman, several attorneys wrote and came to his defense, citing his qualifications and character. We hope they are right.
 New Jersey needs him to get the right job done rightly.

ObamaCare Numbers of Government Don't Agree With News Reports

Editor's Note: This letter was sent to Congressman Holt and copied to the newspaper.

 Congressman Holt: It was nice talking to you on January 11 and for visiting our town of Scotch Plains. As I remember you mentioned that 8 million people have obtained insurance through ObamaCare. However, in accordance with a *Bloomberg Businessweek* report on January 13, they have indicated far fewer numbers.
 In fact it was reported that 2.1 million Americans (recently updated to 3 million) have selected private health plans through healthcare.gov. There are another 1.6 million who joined Medicaid, which is fully funded by the taxpayers and apparently includes those that would have signed up anyway for Medicaid.
 In addition, some for those that have signed up so far that being 33 percent who are 55 to 64 years old and some 22 percent which are 45 to 54 years old make up those that are the ones that utilize significant health care services and potentially cost more money.
 Presently the young that are needed to pay for the health care reform are not signing up in large numbers. Then to make matters worse, some 79 percent are getting a subsidy paid by the taxpayers. Also as indicated on Yahoo, many of the people, who think that they have signed up, never completed the sign up procedure in part because the Healthcare.gov web site did not provide a link to pay for the coverage.
 This makes the 2.1 million sign ups questionable and the 8 million you quoted as a miss-statement at its best.
 I look forward to your comment on these two news articles and your statement during our meeting on January 11.


Objective Clinical Studies Should Compare Marijuana Against Alcohol

To Governor Christie: Persian and Medical Approaches to Marijuana Legalization.
 What's behind this steamrolling momentum to dramatically increase the availability of marijuana? In large part, it's because we have entered the era of post-modernism which is, when exposed, simply a form of nihilism that was prevalent during late 19th century Russia. And you know what happened there. Bottom line, it's an "anything goes" philosophy. It's promulgated in universities, effectively supported by media and now accepted as apolitically popular tool. It's interesting to note that the leaders in this marijuana crusade are two strange bed fellows - liberals and libertarians - both syllogisms abusers. Most conservatives are still trying to hold the line. There was one outstanding exception - the late William F. Buckley, Jr.
 Way back, when many had not yet seen the light of life, I dined with Mr. Buckley in Manhattan over happy Italian food and stimulating spirits. Our conversation was lively, to put it mildly. Suddenly, out of the blue, he asked me what I thought about the legalization of marijuana. I replied that I could only make that judgment after clinical studies objectively evaluated its impact on both mind and body. He remained silent. About 20 years later, he surprisingly supported its broad legalization. His is a social argument which demands respect.
 Now to the great Persian Empire: Before making any final decision on matters of importance, the Persian legislators first considered them while being alcohol-stoned. After their hangovers faded away, they then considered their alcohol-stoned decisions soberly and factored them in their final ones. I would recommend that if the New Jersey legislators want to legalize freely available marijuana, Washington-Colorado style as proposed by Senator Scutari, it should be mandatory that each one should have a bong before them at the plenary first day of deliberations and required to puff away until they are marijuana-stoned. (Perhaps the pro-marijuana legislators should have bigger bongs!) It should be an open session and also mandatory that their families be silently present in the gallery. After the legislators are post-bonged sober they, having considered their bongs deliberations, will be more experienced about the subject matter and, like the Persians, better able to legislate. Governor, what better way is there to confront reality?
 Now to the obligatory medical approach: Though it's of critical importance to standardize the chemical composition of marijuana, there are insufficient clinical data that accurately predict what it does to our minds and bodies. What is sorely needed is at least one solid objective clinical standard, which most New Jersey citizens could understand. And that standard is alcohol. There are reams of clinical data on the scientific, medical and social impact of alcohol both on individuals and society.
 It makes compelling sense to conduct a series of objective clinical studies at New Jersey medical institutions comparing marijuana against alcohol on the mental and physical impact on individuals including their lives. For example, what are their effects on driving performance and cognitive function, among others? What should we do if, for example, the studies show that marijuana intake results in significantly inferior driving and brain performance compared to alcohol? And how about the impact on family stability? The results of these studies would be truly objective - not just guesses - and a rational approach and not an emotional liberal-libertarian one to establish not only New Jersey but national standards, not just for marijuana but certain other drugs.
 Think about it.
